



AFELSCHOOL TERMS AND CONDITIONS

Please read these Terms carefully before using this **AFELSCHOOL** system. By using this system (the "System"), the user ("You") has accepted these Terms of Use. If You do not accept these Terms of Use, do not use the **AFELSCHOOL** system.

We may revise these terms of use from time-to-time. You are encouraged to check back often so You are aware of your current rights and responsibilities. Your continued use of this System after changes to the Terms of Use have been published constitutes your binding acceptance of the updated Terms of Use. If at any time the Terms of Use are no longer acceptable to You, you should immediately cease all use of this System.

Uses of the site

By using the system, you agree to comply with all applicable laws and agree not to:

- Knowingly upload content which is wrong, out of date, irrelevant or misleading.
- Try to register for more than one school account unless allowed by the **AFELSCHOOL** owners.
- Use other users' personal data for any purpose other than establishing contact.
- Attempt to gain unauthorized access to the system, networks, servers or computer systems connected to the system.
- Use automated scripts to collect information from or interact with the System.

Dealing with Improper Use If you post or send offensive, inappropriate or objectionable content on the site, or engage in disruptive or illegal behavior we may use your personal information to stop such behavior. In such cases, we may also use your personal information to inform third parties about the content and your behavior.

Access conditions

You must ensure that all usernames and passwords required to access the Services are kept secure and confidential. You must immediately notify **AFELSCHOOL** ("service provider") of any unauthorized use of Your passwords or any other breach of security and **AFELSCHOOL** will reset Your password and You must take all other actions that **AFELSCHOOL** reasonably deems necessary to maintain or enhance the security of **AFELSCHOOL** computing systems and networks and Your access to the Services.

Annual Software License Fee

If the Customer has opted to purchase the System services, the Customer will be charged for a Software license annually.

The annual Software license provides the Customer with:

- use of the Software for a minimum 12 calendar months.
- maintenance and operating costs of the **AFELSCHOOL** servers.
- selective System updates, improving the running and functionality of the Software.
- The annual Software license fee is currently listed in the price plan on the **AFELSCHOOL** website for each point of sale terminal (as updated from time to time).
- Payment of the Software license is due on the anniversary of the original account activation for each point of sale terminal.
- The Software license fee is non-negotiable and is non-refundable in the event that this Agreement is terminated.
- **AFELSCHOOL** will notify the Customer at least 30 days prior to the Software license renewal date. If the Customer fails to make payment by the renewal date, **AFELSCHOOL** will restrict the Customer's access to the Systems until full payment is made.
